Privacy Policy

Protecting your private information is our priority. This Statement of Privacy describes how Light House Cards Inc. ("[Company]", "we", "us", or "our", "Light House Cards") collects, uses, and shares your personal information if you visit https://lighthousecards.io or our other websites and services that link to this Privacy Policy. This Statement of Privacy applies to anyone who uses or engages with our platform, and Light House Cards Inc. governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Light House Cards Inc. include our websites and all services. The Light House Cards website is a platform which sells generative art-based NFT greeting cards. By using the Light House Cards website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Light House Cards Inc. may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address (of card sender and recipient)
- Payment Information
- Blockchain Wallet Address (of card sender and recipient)
- Blockchain Wallet Public Key
- Message Data
- Zip Code
- Other information that we may collect which is not specifically listed here, but which we will use in accordance with this Privacy Policy or as otherwise disclosed at the time of collection.
- Feedback or correspondence with Light House Cards Inc.
- Usage information, such as information about how you use our Services and interact with our platform
- Marketing information, such as your preferences for receiving communications about our products and activities

Information we obtain from social media platforms. We may maintain pages for Art Blocks on social media platforms, such as Facebook, Twitter, Instagram, and Linkedln. When you visit or interact with our pages on those platforms, the platform provider's privacy policy will apply to your interactions and their collection, use, and processing of your personal information. You or the platforms may provide us with information through the platform, and we will treat such information in accordance with this Privacy Policy.

If you purchase Light House Cards Inc.'s products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Data on the Blockchain

Please note, we have no ability to edit, delete, or modify any information that is stored on a blockchain, as we do not have custody or control over any blockchains. The information stored on the blockchain may include purchases, sales, and transfers related to your blockchain address and NFTs held at that address.

International Data Transfers

We are headquartered in the United States and may have service providers in other countries, and your personal information may be transferred outside of your state, province, or country to the United States or other locations where privacy laws may not be as protective as those in your state, province, or country.

Use of your Personal Information

Light House Cards Inc. collects and uses your personal information to operate and deliver the services you have requested. This includes publishing artwork, wallet addresses and encrypted message data on the blockchain, and storing artwork, wallet addresses, encrypted messages and message data in its unencrypted format on our servers. While we take care to keep such data stored on our servers confidential, we may access any of such data for purposes such as delivering cards to their intended recipient, addressing technical problems, and ensuring that data on our platform adheres to the content restrictions described in our terms and conditions.

When purchasing a card to gift, we share the information provided to us in the card entry fields (including the recipient email address or blockchain wallet address, front greeting, your message, your full name and your email address) to the recipient via the chosen delivery method. As described in our Terms and Conditions, we are not responsible for the exposure of data through the misuse of delivery methods.

Light House Cards Inc. may also use your personally identifiable information to inform you of other products or services available from Light House Cards and its affiliates.

Sharing Information with Third Parties

Light House Cards Inc. does not sell, rent or lease its customer lists to third parties.

Light House Cards Inc. may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address,) is transferred to the third party. Light House Cards Inc. may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. For example, the hidden messages our users write in the NFT greeting cards will go to third parties, such as Crossmint, if third parties are used. All such third parties are prohibited from using your personal information except to provide these services to Light House Cards Inc, and they are required to maintain the confidentiality of your information.

Light House Cards Inc. may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Light House Cards or the site; (b) protect and defend the rights or property of Light House Cards; and/or (c) act under exigent circumstances to protect the personal safety of users of Light House Cards, or the public.

Opt-Out of Disclosure of Personal Information to Third Parties

Tracking User Behavior

Light House Cards Inc. may keep track of the websites and pages our users visit within Light House Cards, in order to determine what Light House Cards services are the most popular. This data is used to deliver customized content and advertising within Light House Cards to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by Light House Cards. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Light House Cards website.

Use of Cookies

The Light House Cards website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run
